James Turcich made a motion, which was seconded by Joseph Parento, to approve the minutes of the March 27, 2018 regular meeting and the April 10, 2018 caucus meeting. The Board was polled. All AYES. The motion was carried.

James Bauer reported the Solicitor is reviewing the membership application form. The bids for the boiler repairs/replacement at Sta 232 are undergoing review.

Chief Martino reported on a few notable incidents: A three alarm mutual aid fire in Willingboro and the Bordentown RIC assignment and assistance.

DEPUTY CHIEF

Deputy Chief Cunningham submitted a written report which is attached and also reported the following items - The township is having the roof replaced on the Municipal Building and area over the Fire District office will be done first. New Antennas were mounted on the Deputy Chief's vehicle. Engine #2321 and Deputy Chief Cunningham will go to the McGuire Air Show on May 5 as part of the coverage requested by the county.
